Skin was warm and dry, Resp even + unlabored, Lung CTA. Abd soft with B5X4 & edema to feet on hand wt 117 lb. 2045 Writer called Dr Nazario about abnormal finding 89% sat on RA. Order rec'd to keep her in infirmary for 23 hr obs, Inmate was schedule for dialysis in AM. Inmate was placed in room 4A-176 and was put in
